



- Aim for A's and B's in all your classes; focus on homework and develop good study skills
- Join clubs, play sports and volunteer. This is a good way to develop and expand your interests
- Explore different career options
- Meet with your high school counselor

# It's Never too Early to Start Preparing for College

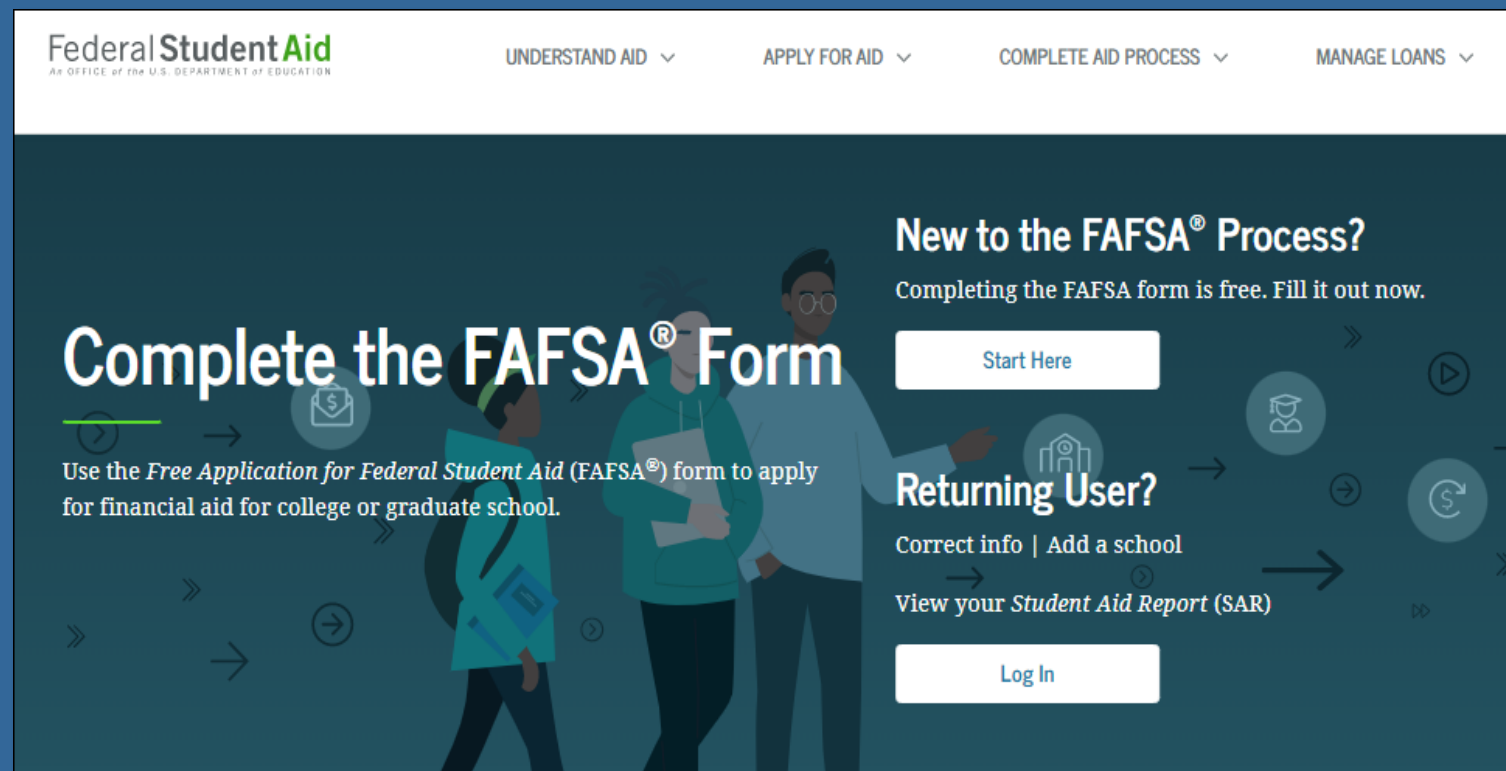
**10-12<sup>th</sup>

- Start researching college degree requirements your sophomore year
- Visit your favorite college campuses starting early spring of your junior year if possible
- Volunteer; get involved extracurricular activities
- Prepare and practice your note-taking skills
- Continue to get good grades
- Continue to meet with your counselor
- **In 12<sup>th</sup> grade:** submit the financial aid application and apply to colleges after **October 1st!**



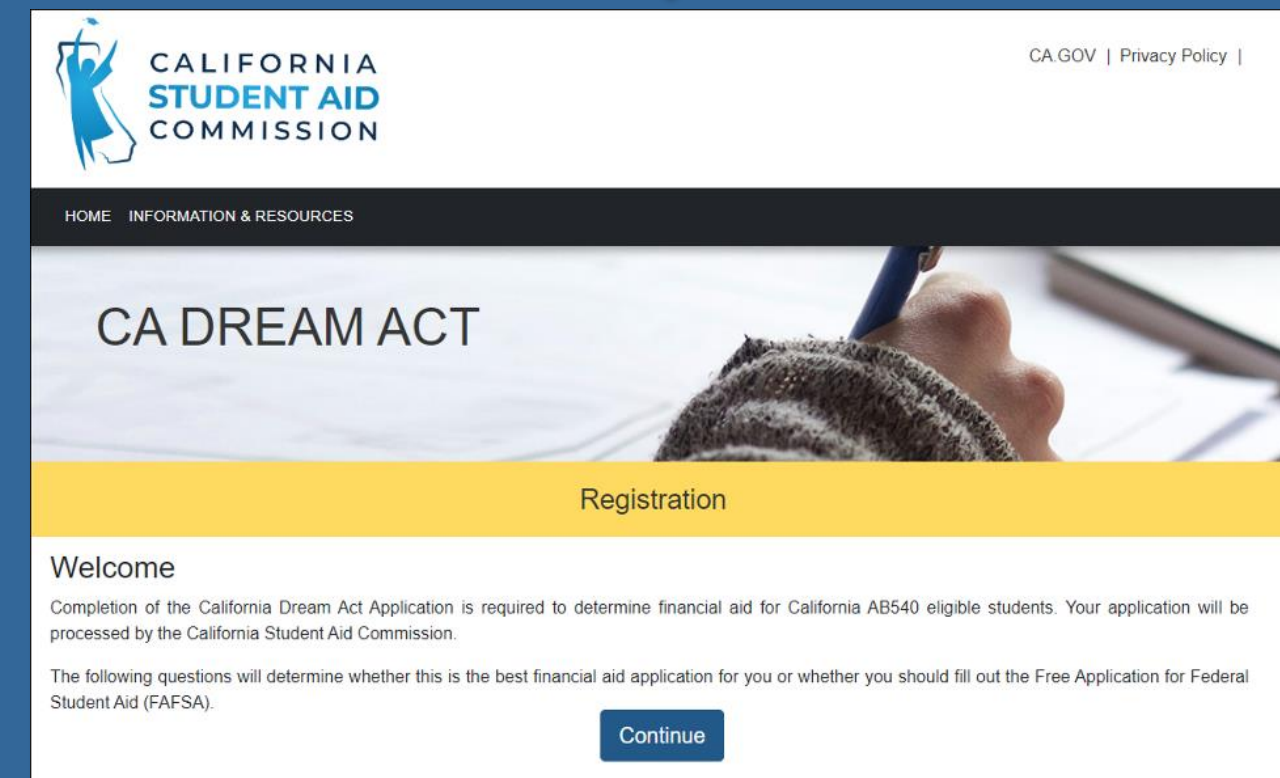

# Before you Begin Either Application



Before you begin an application, please be prepared to take notes. it is important to write down (or take a picture of) things such as;

- ✓ Full name of student as entered
- ✓ Usernames & Passwords
- ✓ E-mail Address Used
- ✓ Pin Numbers
- ✓ Secret Questions and Answers



# Email and Postal Addresses



Provide **email** and postal **mail addresses** and telephone numbers that will remain active through the end of the admission and financial aid application periods.

It's better not to use the student's school or district email if possible. Also, try not to use a family e-mail address that is shared by the entire family. Students need to check their e-mails on a regular basis.



Students should create an e-mail account specifically for financial aid applications and college applications.

# **We make a lot of money. Why bother to fill out a Financial Aid Application?**

- One of the big reasons to go ahead and fill out the FAFSA or CADAA is the fact that it could unlock some financial aid beyond federal grants and state aid that require you to demonstrate financial need. A completed application also opens doors to scholarship opportunities that are not necessarily based on financial need.
- A financial aid application is more than an application for financial aid today — it's a backup in case of a catastrophe tomorrow! Think of it as an “insurance policy” in the event of job loss, divorce, unexpected medical bills, etc.
- It's free to apply and takes less than an hour!

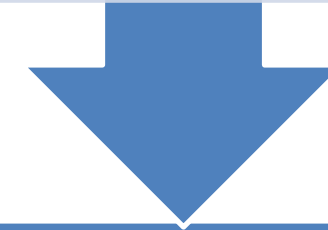

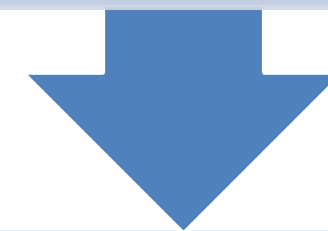

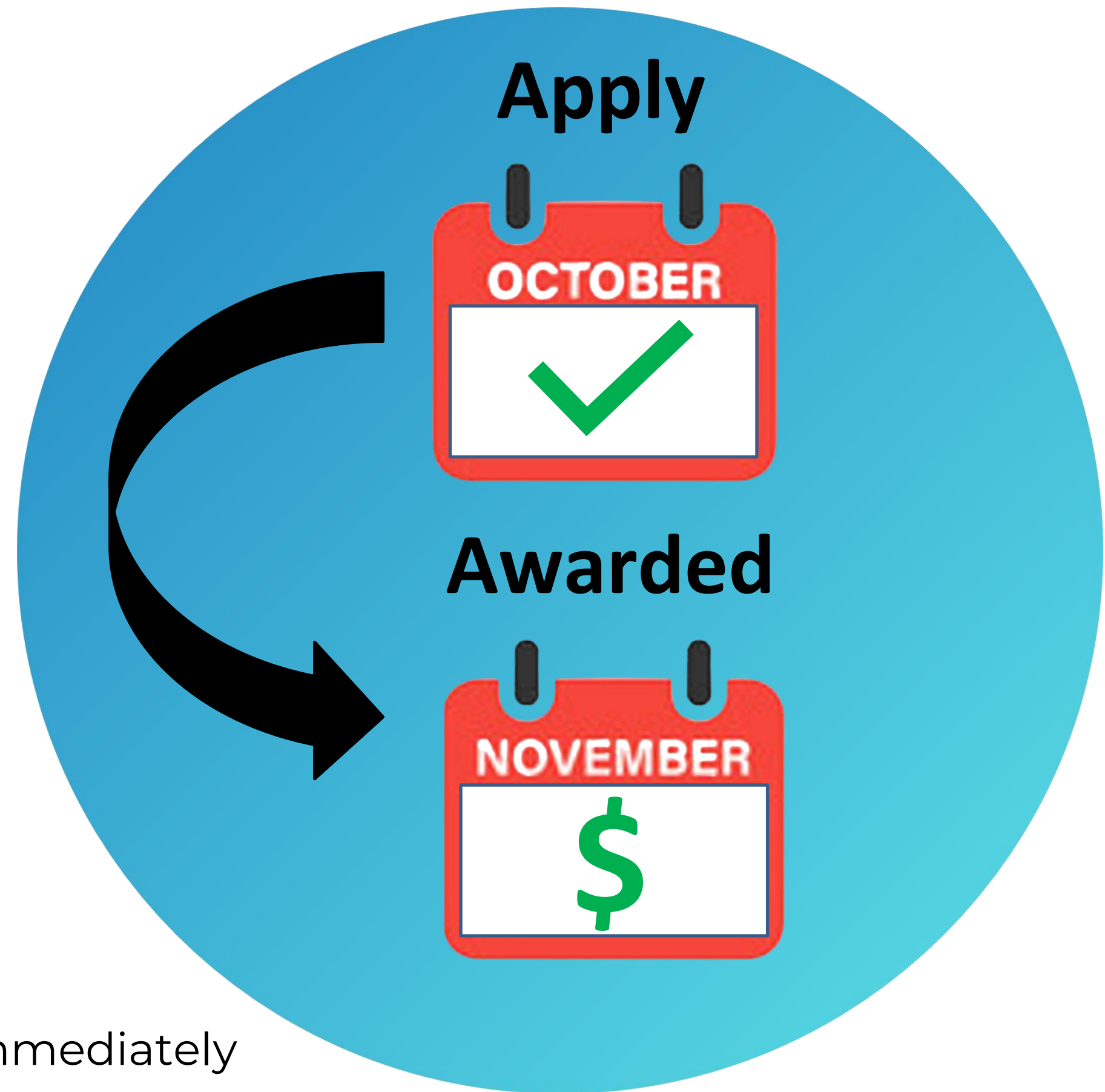

# Apply Early!

- Students who apply in early October can receive a Cal Grant Eligibility Notification as early as November
- They'll know if they are eligible to receive thousands of dollars in free money for college or vocational training
- Applying early also gives students a better opportunity for “**first come, first serve**” financial aid

**FAFSA** takes 3-5 days to process

**CADAA** (proprietary to CSAC) processes almost immediately

# FAFSA Filers - Creating an FSA ID

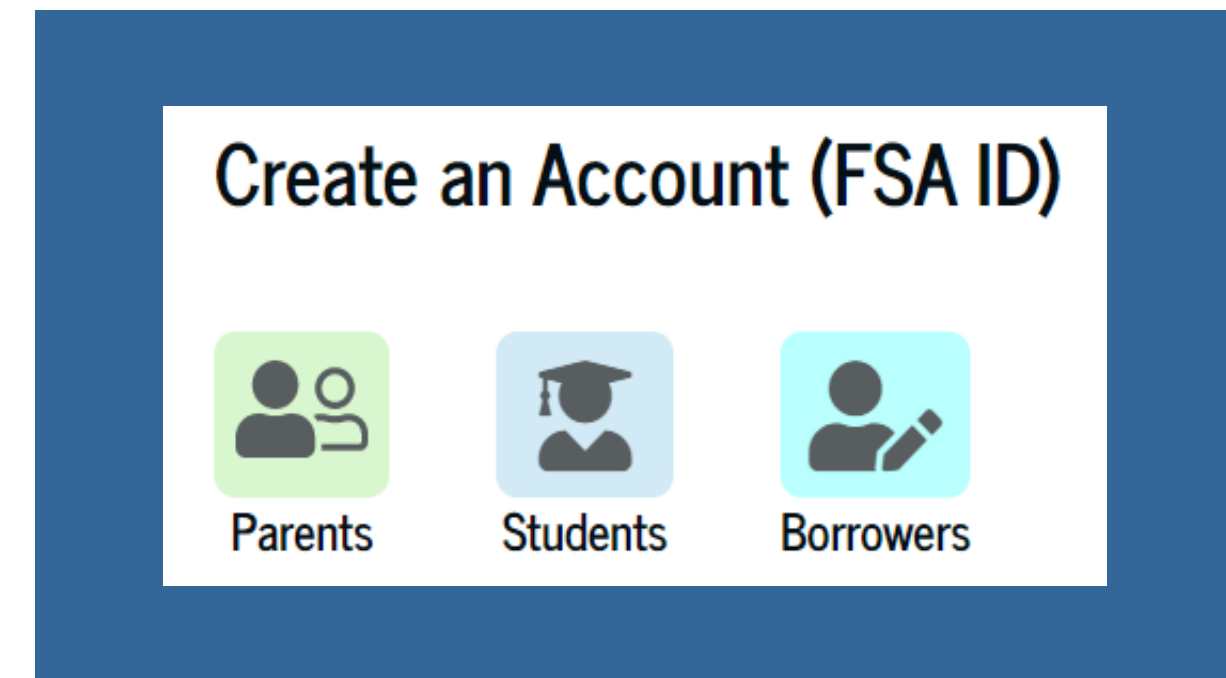
- If you do not already have an FSA ID, you will need to create an FSA ID. You will use this to sign your completed application
- If you are a 'dependent' student, a parent will also need to create an FSA ID (with a separate e-mail)
- If you have an FSA ID but do not remember your username, select "Forgot Username" on the FAFSA login page

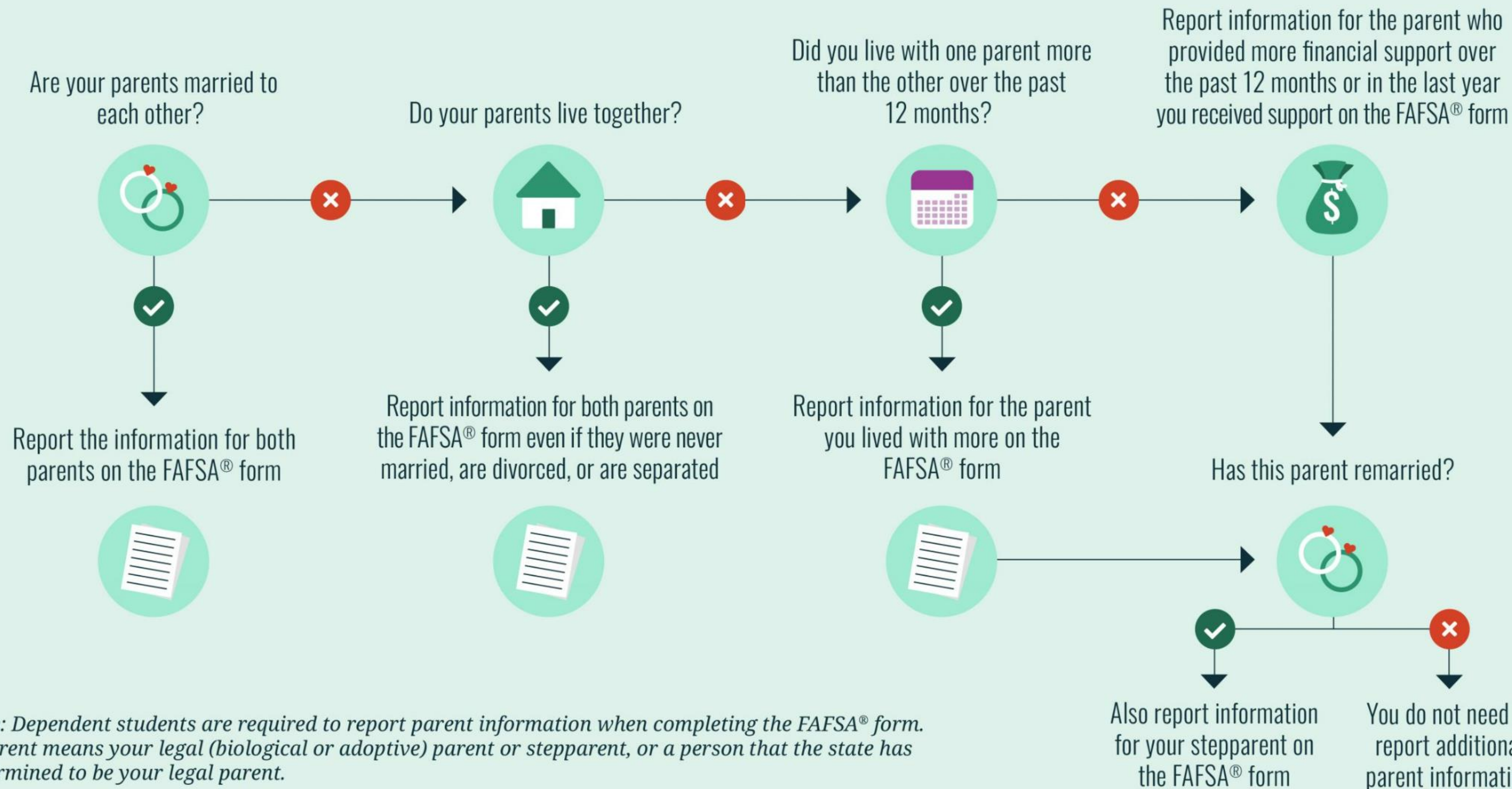
# FSA ID

The FSA ID is a digital signature used to sign the FAFSA, Direct Loan and Parent PLUS loan Master Promissory notes, and to access federal student aid sites.

- Student creates their own
- Parent creates their own
  - SSN and Date of Birth needed
- Common mistakes:
  - SSNs switched
  - Parent creates password for student, or
  - Student creates one for parent
- Can log in with a verified mobile phone number

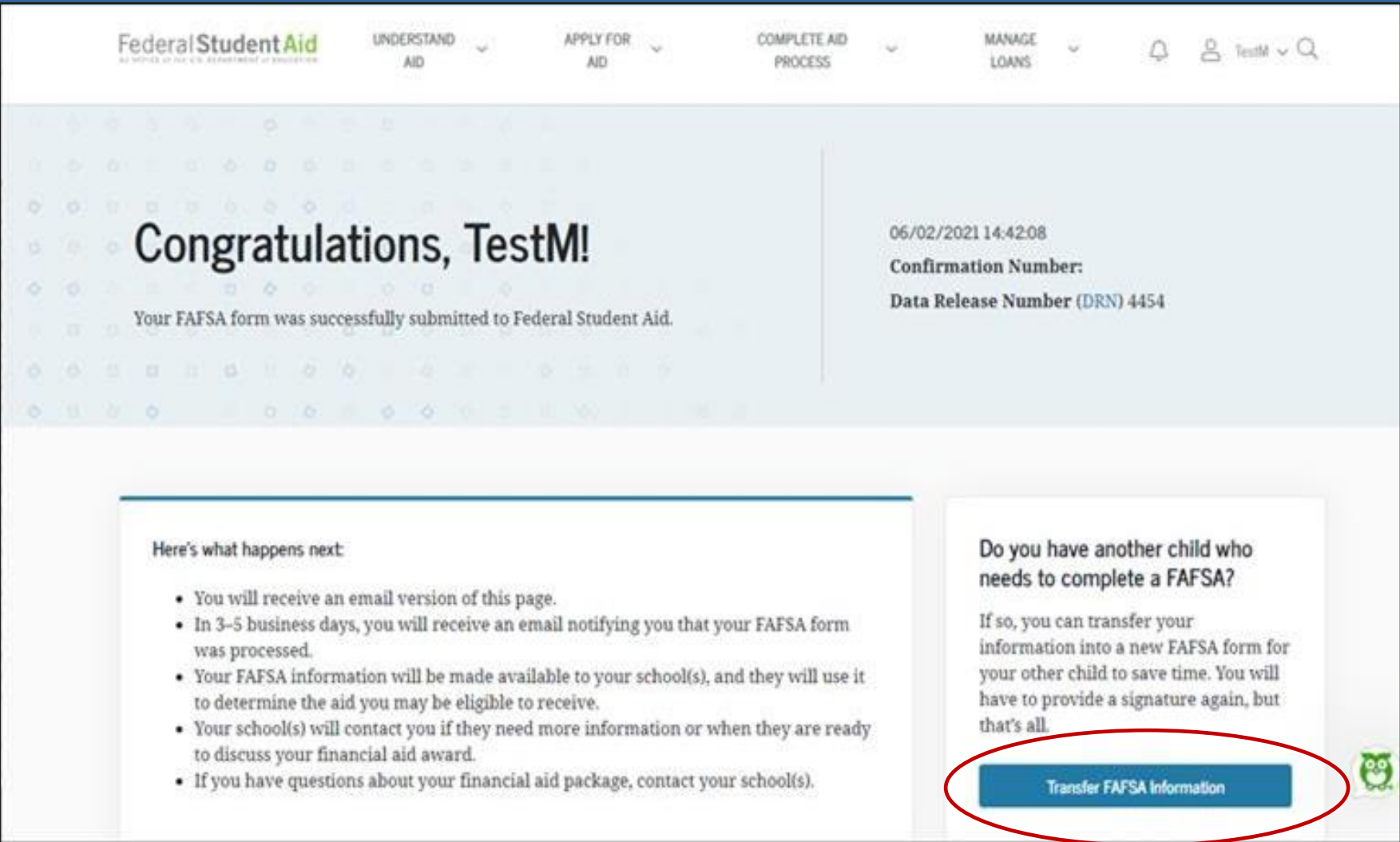

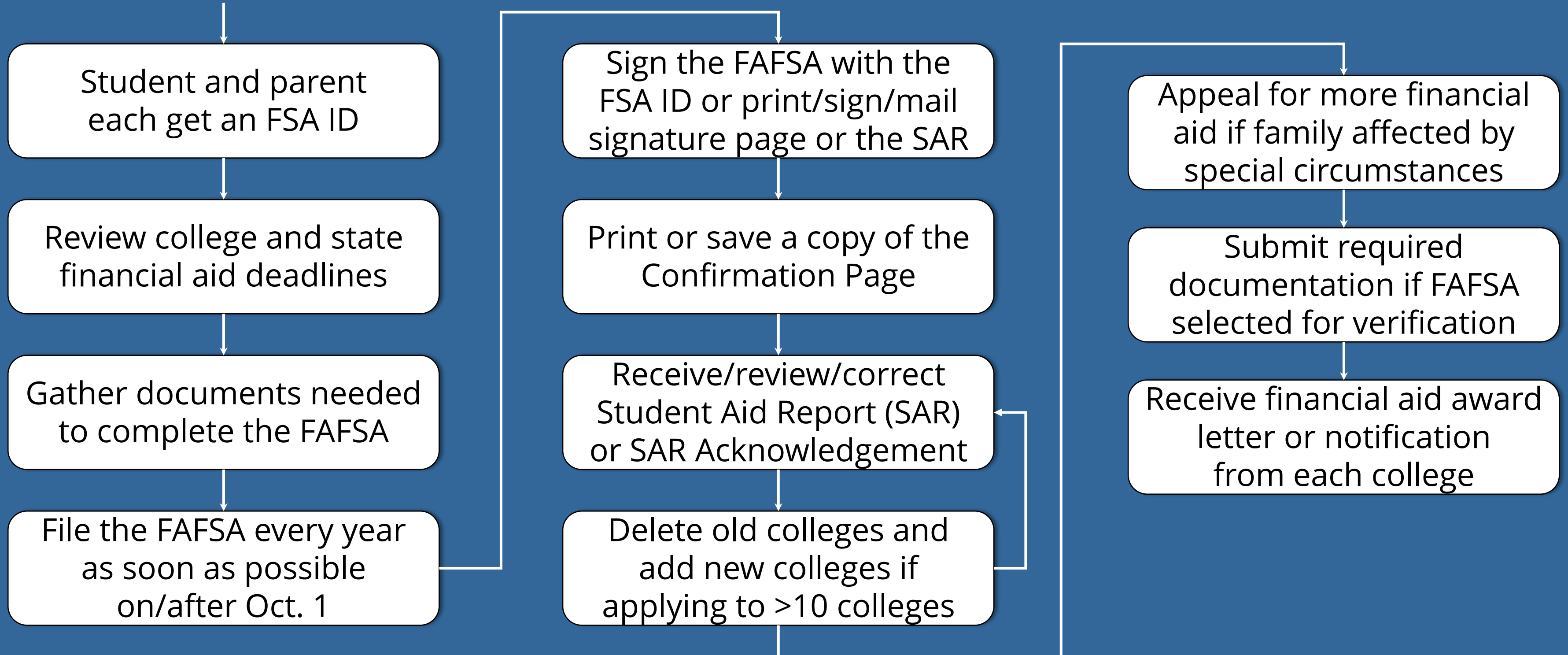

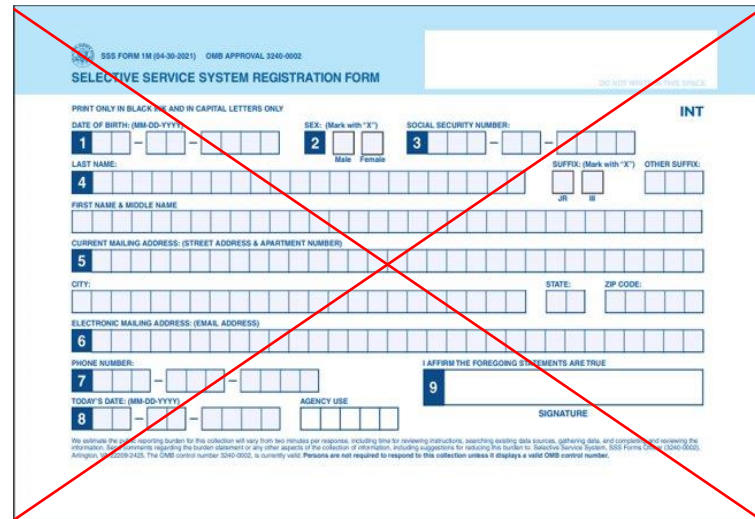

# Completing The CADAA

- Complete the three sections listed as tabs at the top of the screen. The website will take the student through each section
- Click “Save Application” at the bottom of the page to save your responses. Click “Next” at the bottom of the page to go to the next section
- For detailed instructions and information about each question, click the information icon
- The answers to some questions will be prefilled with your registration information
- It is critical that students complete the application with their correct name and date of birth

## GRANTS

FREE Need-based money that doesn't need to be repaid. Federal, state, and campus grants are available.

FREE Merit-based money that doesn't need to be repaid.

## SCHOLARSHIPS

## WORK STUDY

A federal program that allows students to work on campus and earn \$. Earnings applied towards tuition, fees, etc.

## FEDERAL LOANS

Fixed, low-interest rate money that must be repaid after graduating college.

# Middle Class Scholarship (MCS) 2.0

Students enrolled at a UC or CSU whose income exceeds the limits for a Cal Grant, will automatically be considered for the **Middle Class Scholarship** if they applied on time with the FAFSA or the California Dream Act Application by March 2<sup>nd</sup> and they plan to attend a UC or a CSU. For the **2023-24** academic year, students with family income and assets up to **\$217,000** may be eligible.



**NEW**

Beginning in 2022-23, a student's initial Middle Class Scholarship award determination will be based on the **Cost of Attendance** for the school the student chooses to attend, taking into consideration any other aid or fee waivers the student is receiving.

Once the new program rules take effect in 2022-23, the number of MCS recipients is estimated to increase from about **60,000 to about 360,000.\***

# E3

## Community College Entitlement Cal Grant

September 2<sup>nd</sup> deadline

- Implemented in the 2021-22 academic year
- Greatly increased the number of students eligible for financial aid at California Community Colleges
- Eliminated more than half of competitive awards from 41,000 to 13,000 but added **TENS OF THOUSANDS** of additional Entitlement Cal Grant awards
- Beneficial to students who missed the March 2<sup>nd</sup> deadline but are planning on attending a California Community Colleges



# California Dream Act Service Incentive Grant (DSIG)



- **New!** Up to 1,667 Cal Grant B\* Service Incentive Grants of up to **\$4,500** per year!
- Students perform 300 hours of community or volunteer service and attend a California public colleges or private, non-profit institution
- **New!** removes the “proration” of awards, and now provides stipend awards without regards to a student’s part-time or full-time status

\* or a Cal Grant A award that met the initial criteria for a Cal Grant B.



# NEW! Californians For All College Corps

- Up to 6,500 undergraduate students who complete a year of service (450 hours) will receive \$10,000 plus potential academic credit
- AB 540 Dreamers are eligible to participate but must apply for the California Dream Act Service Incentive Grant program
- Program begins in the Spring of 2022
- Students can apply beginning in March 2022 (check website for updates)
- 45 colleges and universities will be part of the program roll-out

# Students Can Also Consider Vocational, Occupational or Technical Programs

- Trade schools or community college vocational training courses can provide some students with an alternative to four-year college programs
- Potentially lower tuition costs and shorter degree pathways are benefits of trade schools or community college certificate programs
- Career-focused, practical training can help students pursue in-demand jobs
- Cal Grant C: Free money to attend a vocational, occupational or technical program





# Alternative Sources of Financial Assistance



Students can look for private scholarships. There are many websites that allow you to search for available merit scholarships including Fastweb.com and similar sites.



Students should check with local service organizations, credit unions and business organizations that may offer scholarships for college.

Students may want to consider working part-time at a company that offers college tuition assistance or tuition reimbursement.



*“I’m a first-year college student at a community college and I have a Cal Grant B. I know I can put it on hold for two years, or even more, but I don’t know if I should. What do you advise? Should I put a hold on my Cal Grant B Access Award until I transfer to a four-year college?”*

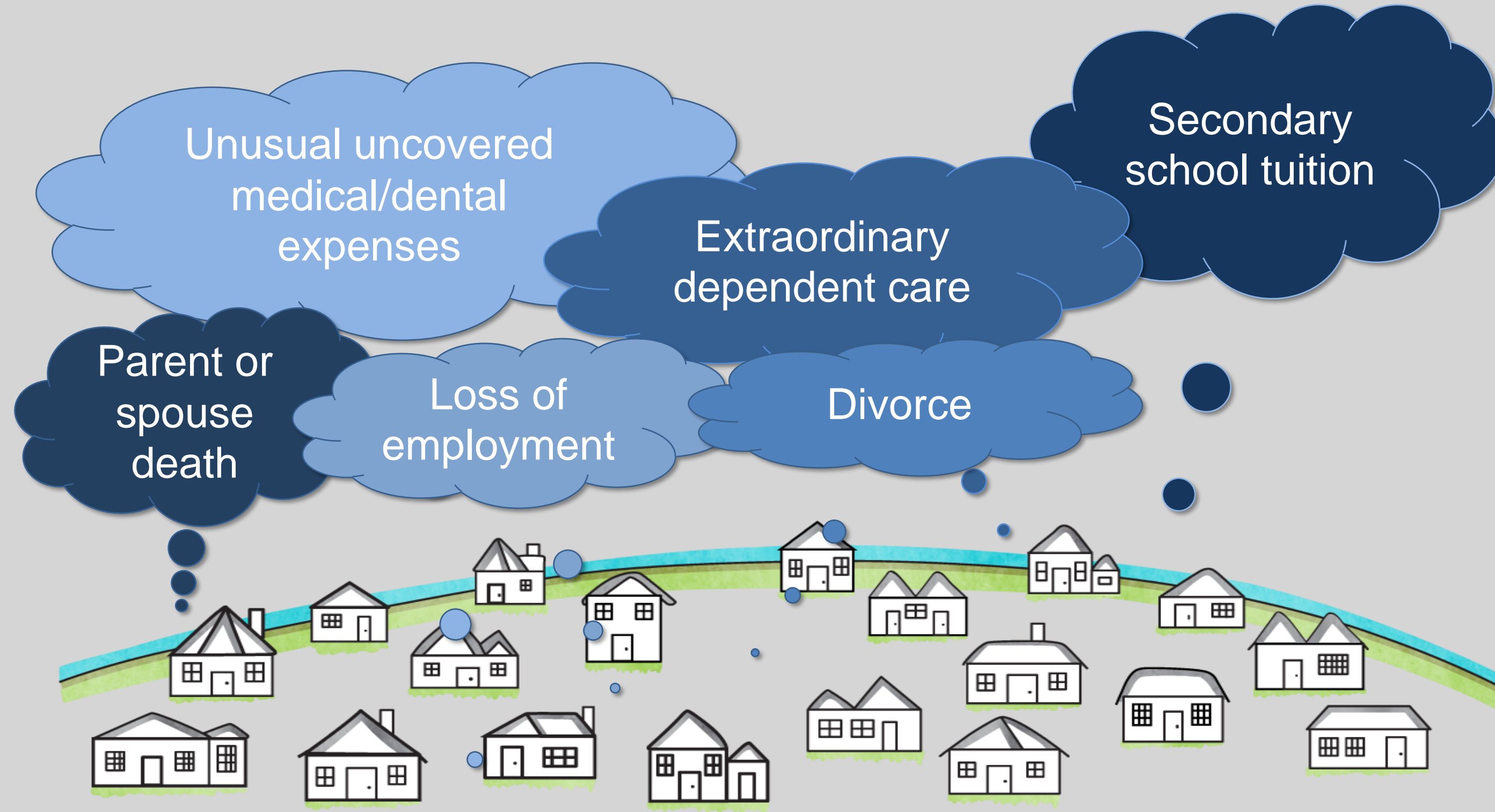
# Taking a “Gap Year”

- High School Students who receive a Cal Grant but don't wish to use it immediately can place it “on hold” until they return to college
- A Cal Grant ‘Leave of Absence’ can be placed for as little as one quarter/semester or up to 200% of the award eligibility (2 academic years). The holds do not need to be consecutive
- When a Leave of Absence is placed on the Cal Grant, no eligibility is lost for that period





# Special Circumstances



# Special Circumstances

## Income Adjustments

- Reduction of earnings
  - Employment status
  - COVID-19 Pandemic
  - Loss of benefits
  - Marital status
  - Medical/Dental expenses not covered by insurance
  - Unusual dependent care expenses

## Dependency Status

- Make a dependent student independent if unusual circumstances exist
  - Abusive family environment
  - Abandonment by parents
  - Inability to locate parents

# Financial Aid Appeals

---

- Appeal for more aid if the family is affected by special financial circumstances
- Provide documentation of the special circumstances and their financial impact
- Adjustments are more likely if the circumstances were beyond the family's control
- Families can appeal for more aid at any time, even in the middle of the academic year
- A free tip sheet about how to appeal for more financial aid is available at [kantrowitz.com/books/appeal/](http://kantrowitz.com/books/appeal/)



Have students complete their applications as soon as possible **beginning October 1<sup>st</sup>**, but no later than the March 2<sup>nd</sup> priority deadline. More aid may be available for early filers

Have students apply for financial aid **regardless of income**

Instruct students to add **at least one California college** on their financial aid application, even if they plan to study out-of-state

Instruct your students to go to **[mygrantinfo.csac.ca.gov](https://mygrantinfo.csac.ca.gov)** to create their 'WebGrants 4 Students' account after they complete their application. Students can check their status and **confirm that a GPA has been uploaded**

Remind students to **check their e-mail** (including 'junk' and 'spam' folders) on a regular basis. We recommend that students not use a high school or district e-mail for financial aid or college applications

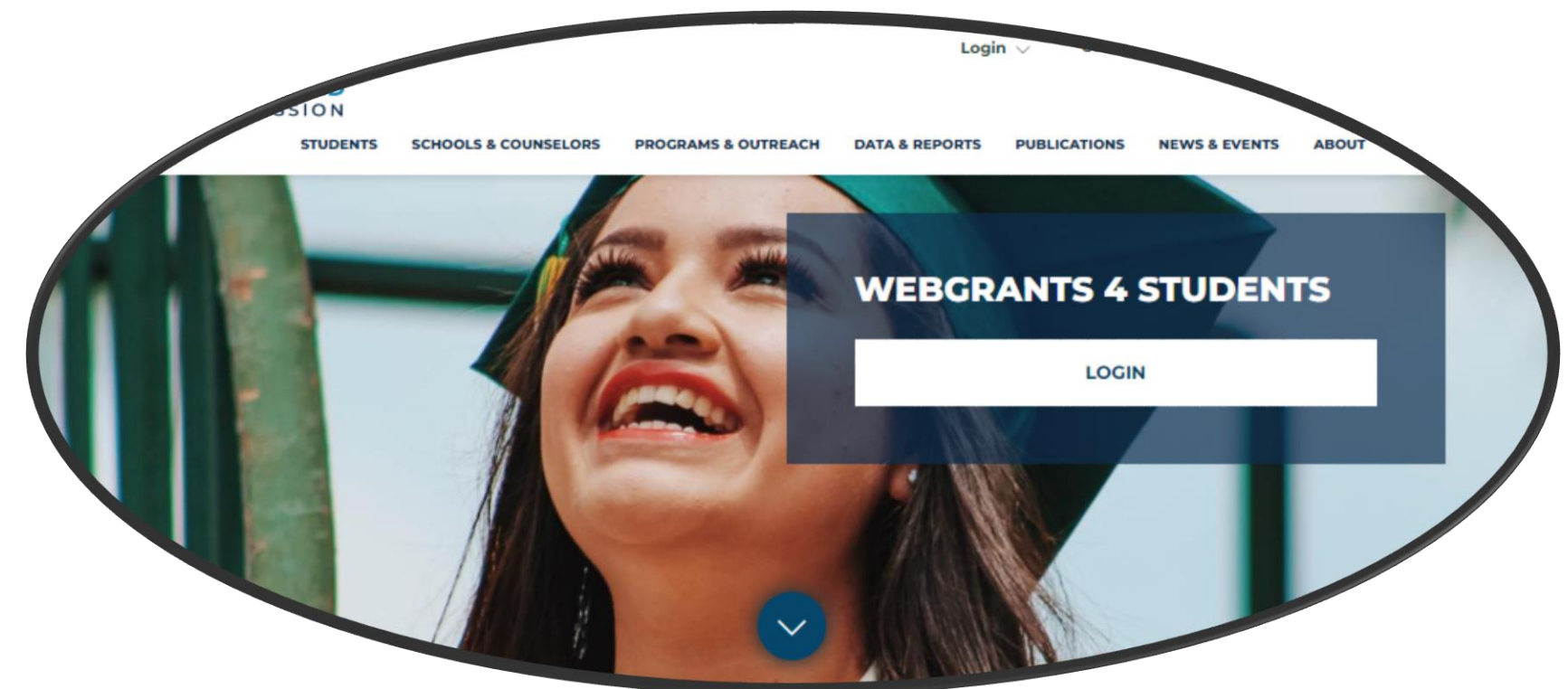
